Tanker/Vehicle Accident		Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111								
Spill or leak	clothing	Keep all bystanders away. Wear goggles, half face-piece respirator with combined dust and vapour cartridge, full length clothing and PVC gloves. Sweep up spilled product and place in a sealable container for disposal. Wash down affected area with water plus detergent. Seek advice from local authority regarding disposal.								
Fire		<b>Call the Fire Service</b> : <b>Dial 111</b> . Wear PVC protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical or carbon dioxide. During a fire, toxic fumes may be released. Contain run-off. Keep non-involved persons away.
